Chairperson Kevin Taylor opened the meeting at 1:00 p.m.

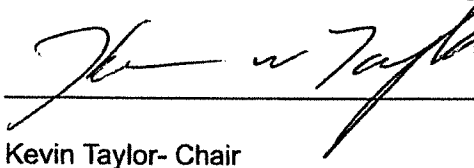

 - Kevin informed her that the board needs time to respond to some complaints and that he believes that this is an easier way to meet the citizens needs.

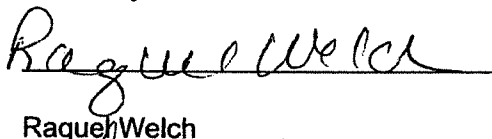
Larry motioned to adjourn the meeting at 2:50 pm., Seconded by Kevin. All in favor.



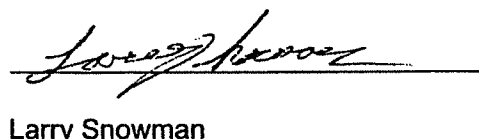

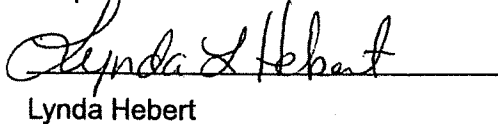

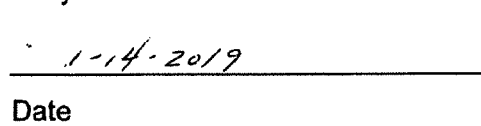
